 - i. Fernando Zulueta discusses that as a result of the school closures due to COVID-19, there has been overwhelming parental support; we are getting a lot of requests from parents to continue this mode of learning in the fall; we will seek guidance from the state regarding the manner and hoping that the regular charters can continue to offer virtual education; however another option could be to enroll in the virtual school, so we would like to request to add grades K-5 to the charter and increase enrollment without a cap to best service the community.

Discussed applying for virtual charters outside of Miami-Dade county; discussed the cooperative agreement with the other networks; Board Member Blanch addressed the long term plan to consolidate the existing virtual schools and apply under the name of the consolidated charter; Board and staff discuss and feel that they should focus on the actual application now and can determine the name at a later date.
 - i. **APPROVED**: The Board approved to authorize the submittal of a new charter school application for a virtual school outside of Miami-Dade County.
